# **CONTEXT**

The goal of this investigation was to identify the attitudes, knowledge, and practice habits of healthcare clinicians who specialize in these seven forms of cancer.

# **SURVEY**

A total of 1,528 self-identified LGBTQ adults (18 years of age and older) participated in the survey, which was conducted between June 9 and June 30, 2020, utilizing the American Speak online panel maintained by NORC (National Opinion Research Centre). The Competency Assessment Programme (CAP) was able to identify results that were pertinent to significant community subgroups, including race, age, education, income, handicap, gender, or gender identity, because of the size of the overall sample. The complete study results are available for review by the authors, together with an extensive methodology overview. According to the survey's findings overall, a large number of LGBTQ people still experience prejudice in their personal lives, places of employment, public settings, and when trying to obtain essential medical care. Numerous detrimental impacts of this bias are seen in their physical, emotional, and economic well-being. Numerous LGBTQ individuals report that they have altered their lives to avoid discrimination and the psychological distress that results from receiving unfair treatment. Compared to older generations, younger generations report higher levels of discrimination and related concerns. Transgender individuals, people of color, and persons with disabilities are particularly likely to experience discrimination-related challenges. This group experiences more anxiety due to the corona virus, especially the most vulnerable individuals in terms of their health or status as front-line workers.

### POSITIVE ATTRIBUTE

We are aware of the possibility that senior attorney Saurabh Kripal would be India's first homosexual judge. After four years of deliberation, the Supreme Court collegiums have finally approved his appointment as a judge of the Delhi High Court. It's a common legal claim that the delay in recommending his name was due to his sexual orientation. If he is chosen, his appointment will signal a watershed moment in LGBT rights. This means that everyone may achieve anything he or she desires, improve his or her level of living, and lead and live life responsibly and with dignity without hesitation or pressure.

### IRONY OF THE SOCIETY

In other parts of the nation, family-sanctioned corrective rapes—which are often performed by family members—are committed against lesbians. Lesbians and transmen in rural areas,

according to Vyjayanti Vasanta Mogli, a transwoman LGBT activist and public policy scholar at the Tata Institute of Social Sciences in Hyderabad who has made no secret of her abuse at school, are at the bottom of the human rights hierarchy within the family and village unit.

She cites B.R. Ambedkar when talking about the socioeconomic environment in rural areas. "Ambedkar saw the village as a unit of violence, and this is especially true for LGBT problems." She asserts that "Village doctors and babas sometimes advise rape to cure lesbians of homosexuality." Refusing to be married leads to more physical abuse. Lesbian suicides make headlines in educated urban India every year, but stories about family acceptance that you see on TV and in other media are more common in metropolitan areas. Not surprisingly, then, a panel has concluded that the biggest risk lesbians in India face comes from inside their own families.

In India, the majority of people have a negative view of LGBTQ individuals. This is owing to the ancient beliefs and customs of Indian culture, which are still strongly ingrained in the nation. We are more inclined to select a society where people are connected by love, equality, and respect, yet in the same society, many individuals around us have their sexual orientation, which we cannot ignore. The irony is that we show acceptance but fail to put it into practice. If I offer a clear example of situations in India, we label a gay person a 'hijada' and they still beg on the streets for money, doing nothing new. People also refer to one other as 'hijada' while abusing each other, which is utterly disrespectful and degrading to the person being called by that word.
